

# Sea Japan 2024 / Offshore & Port Tech 2024

## Exhibitor Presentation

This presentation plan is available only for exhibitors at this exhibition (Sea Japan 2024 / Offshore & Port Tech 2024). The presentation plan allows exhibitors to promote their products, services, and technologies to visitors outside of their own stands. Two types of presentations are available: (1) "Online Pre-Exhibition Presentation," which is delivered online prior to the show, and (2) "Onsite Presentation," which is given onsite during the show, to appeal to a wide range of visitors.

Presentations by exhibitors or co-exhibitors at this exhibition should, in principle, be related to the products, services, technologies, or corporate image of the presenting company.

### How to apply

Please submit the "Contract Form for Exhibitor Presentation" to the Secretariat at the same time as or after submitting your "Booking Form" for participation in the exhibition.

### 1) Online Pre-Exhibition Presentation

Webinar platform: Zoom

Maximum number of participants: 500

Date & Time: Mid-March 2024 (tentative) \*Date and time of the presentation will be adjusted with the Secretariat later.

Duration: 30 mins per session / 45 mins per session

Participation fee: 30-mins slot = JPY 200,000(tax excluded), 45-mins slot = JPY 250,000(tax excluded)

Promotion: The date, time, theme, and company name of the presentation will be posted on the exhibition invitation, the official website, and in newsletters. In addition, other detailed promotion will be conducted by the Secretariat. Audience registration method: Pre-registration is required for each session.

\*After the seminar, the Secretariat will conduct a questionnaire survey of the audience and provide the applicant company with the data of those who responded to the survey and request for information materials or business meetings.

Operation method: The Secretariat will distribute the recorded data received by the applicant company.

The Secretariat can also provide support for webinar recording.

\*Optional Webinar recording support: JPY 50,000(tax excluded) \*The archive will not be distributed.

Duration: 30 mins per session (including Q&A time) \*5 mins set-up, 5 mins clear-up time excluded

Participation fee: JPY 60,000 per session (tax excluded)
